THE SHELTER HOUSES 18 WOMEN AND CHILDREN OF ALL AGES EACH NIGHT, AND PROVIDES OVER 6,500 BED NIGHTS (ONE PERSON/ONE BED/ONE NIGHT) EACH YEAR.

THE EMERGENCY SHELTER PROGRAM PROVIDES FOOD, CLOTHING, PERSONAL CARE ITEMS, AND PROVIDES FOR EMERGENCY BASED NEEDS. INTERPRETERS ARE PROVIDED FOR ALL SERVICES, WHICH INCLUDE INDIVIDUAL ADVOCACY-BASED COUNSELING, AVAILABLE 24 HOURS A DAY, SHORT-TERM MENTAL HEALTH THERAPY, WEEKLY SUPPORT GROUPS (INCLUDING A GROUP FOR WOMEN DUALY IMPACTED BY DOMESTIC VIOLENCE AND CHEMICAL DEPENDENCY), ASSISTANCE WITH HOUSING, FINANCIAL AND OTHER RESOURCES, MEDICAL SCREENING, AND LEGAL ADVOCACY
